# ASSE Cross Connection Control Recertification

This class will provide renewal for Testers, Surveyors, and Repairers. At this 8 hour training, participants will review the guidelines used for acceptable practices of testing backflow prevention devices. The participants will receive the information and skills to help them pass the American Society of Sanitary Engineering (ASSE) Recertification Examination. At the end of the training the recertification exam will be given. This consists of a written and hands-on exam. This training is mandatory in order for the student to recertify under ASSE guidelines.

Must have valid ASSE Tester Certification.

*\*Participants will need a laptop for evening work and studying for this course. Laptops will be provided for in-class use. If you require a paper copy of the materials, it can be provided at an additional cost of \$250. Effective January 1, 2018 all exams will be given by computer.*
