Wastewater Biomass Enhancement & Bioaugmentation: This course presents the four components that provide for biological improvement or recovery of wastewater treatment processes (addition of organisms, major & minor nutrients, essential enzymes, and critical growth factors. A comparison of rumen microbiology and bioaugmentation is also presented.

Activated Sludge: Process Control Tests & Parameters: This course provides the operator with reliable, often rapid, tests for early detection and troubleshooting of undesired changes in the steady state and acceptable operational condition.
