- How to Take a Digital Photograph of a Sanitary Sewer Manhole

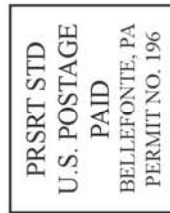
### PRWA Training Event Safety
