# ASSE Backflow Prevention Assembly Testers Repair / Recertification

## 22 WATER AND WASTEWATER CONTACT HOURS

The course is designed for water and wastewater treatment plant operators, plumbers and maintenance personnel. The purpose of the course is to give already certified backflow prevention assembly testers, detailed instruction on diagnosing problems in backflow devices using a differential pressure gauge and then disassembling it and making necessary repairs. This course is designed to bring together everything that may have been learned in other classes. This course has been approved by the ASSE (The American Society of Sanitary Engineers) and therefore meets ANSI Standard Series 5000.

**This is good for new repair certification and also repair recertification.**

**\*Participants will need a laptop for evening work and studying for this course. Laptops will be provided for in-class use. If you require a paper copy of the materials, it can be provided at an additional cost of \$250. All exams will be given by computer.**

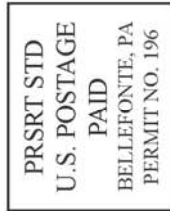
