32 WATER AND WASTEWATER CONTACT HOURS

The course is designed for water treatment plant operators and administrators who would be involved with drafting and/or implementing a comprehensive cross-connection control program including an annual testing and tracking program. A hands-on testing workshop will allow students to practice test procedures on the reduced pressure principal assembly, double check valve assembly, and pressure vacuum breaker. ASSE test procedures will be reviewed and taught in the classroom and then put into practice in the Wet Lab.

***Participants will need a laptop for evening work and studying for this course. Laptops will be provided for in-class use. If you require a paper copy of the materials, it can be provided at an additional cost of \$150. All exams will be given by computer.**

Exam will be given the final day of the course.

Prerequisite: You must be a Certified Backflow Prevention Assembly Tester certified by ASSE, NEWWA, ABPA or BMI to take this course. Successful completion of this course will also renew your Tester, Surveyor, or Administrator Certification
